# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to 4cast, 4site, and Blue Bison Analytics, Inc. and governs data collection and usage. The BBA application is an oil and gas software application. By using the BBA application, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, BBA may collect personally identifiable information, such as your:

- First and Last Name
